

C & C Driver Training Academy-Consent Form

This form must be signed by both the student and the parent/legal guardian (if under 18 years of age). If the applicant is over 18 years old the form must be signed and dated by the applicant.

DIGITAL CLASS

1. All digital classes must be completed before the student can start the in-car portion of the program,
2. All fee's must be paid in full before in-car lessons can begin (unless approved by the office)
3. MTO rules stipulate that the full program must be completed within 1 year of the start of the digital in class lessons. The full program includes 30 hours of digital learning (this includes the 10 hours of homelinks assignments) as well as 10 hours of in-car lessons.
4. Students must obtain at least 70% average to pass the in-class

IN CAR LESSONS

1. The instructor will contact the students with available dates and times. It will be up to the student to pick the time they would like to go and put their names on the schedule.
2. All communication regarding scheduling will be done through the schedule the instructor gave you. If you need to make changes, please contact your instructor. It is the student's responsibility to keep track of when their lessons are after they are booked. The students will not receive a call before every lesson to confirm.
3. There is a strict 24-hour policy to cancel or change appointments. Medical reasons are the exception. The charge for no show or not giving 24 hours' notice or you do not have your G-1 will be \$20.00 per 1 hour missed or cancelled lesson.
4. There is a 15-minute grace time for the instructor as well as the student. It is the responsibility of the student to find the instructor for all pick up locations. If your instructor is not at your pick-up location within 15 minutes, please call or text your instructor.
5. LESSONS ARE SUBJECT TO CHANGE by the school/instructor. We will do our best to notify you of changes as soon as possible. This may happen due to mechanical issues or Road Test Rentals
6. We recommend a minimum of 2 hours of practice for every hour taught by the instructor, the more practice a student receives the greater their chance of passing their Road Test.
7. Students will be given a driving test on their last in-car lesson and must obtain 80% to qualify for MTO certification.
8. Car Rental on the day of road test is NOT included in the program fee.
